## **Acceptable Use Policy**



## Purpose

- Give the impression that they emanate from D5 Design if this is not the case
- Advocate, promote or assist any unlawful act

## Suspension and termination

We will determine whether there has been a breach of this acceptable use policy through your usage of our site. When a breach of this policy has occurred, we may take such action as we deem appropriate.
